The office of the ACAS Board member requires committed individuals with top moral standards. Has in this particular case that standard been questioned since the mentioned candidate did not have enough time, knowledge and willingness to participate in drafting the *Model Whistleblowers Protection Act* in consideration of revenues he has been receiving from the Government budget on the basis of his numerous functions and offices? However, for participation in the work group that you have established and which you manage within the project of drafting the anti-corruption law, financed by the governments of Great Britain and the Kingdom of Netherlands with 100.000 EUR, your candidate does have time and willingness.

Mr.Šabić and Mr.Janković, we note that, while on one hand you permanently and vocally call out the Government agencies for lack of transparency, on the other hand and simultaenously, you stubbornly and intentionally refuse to give information of public importance within your sphere of influence and which are of great importance in fight against the corruption. Such hypocritical attitude from top officers of independent institutions is a drastic example of double standards which ruin the foundations of the Rule of law and represent a potent stimulus to systemic corruption in Serbia. We will inform the Speaker of the National Assembly of your unacceptable behaviour as well as all relevant international institutions which have in the past years supported the formation and work of the Ombudsman and Commissioner for information of public importance.
