Under auspices of the Chamber of Medical Institutions and with the support of the Ministry of Health (MoH) and Anti-Corruption Agency (ACAS) on 03.10.2013. a presentation was held of the project called "Hospitals Without Corruption ", financed by the USAID within the Project for reform of judiciary and responsible government.
